# SUPPLEMENTAL/BID BULLETIN NO. 1

Please be advised of the following clarifications to the Bidding Documents raised during the Pre-Bid Conference held on July 16, 2018:

# I. Section III. Bid Data Sheet

> 12.1(a)(ii) - Statement of All On-Going Government and Private Contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid.

The Bidder shall submit the required statement by using the prescribed format in Section VIII. Bidding Forms, p. 86. No attachment required. Submitted list shall be subject for verification during post-qualification process.

12.1(a)(ii) - Statement of Single Largest Completed Contract (SLCC)

The Bidder shall submit the required statement by using the prescribed format in Section VIII. Bidding Forms, p. 87. The Single Largest Completed Contract (SLCC) similar to the contract to be bid, within the past five (5) years prior to the date of submission and receipt of bids, the value of which must be equivalent to at least 50% of the ABC. The Bidder shall attach Certificate of Satisfactory Completion issued by the client for the SLCC.

# II. Structural As-Built Plan

As required under Section VI. Schedule of Requirements and Section VII. Technical Specifications, the winning bidder shall provide Structural As-Built Plan (for NDC and I&I Buildings) duly signed and sealed by a licensed Structural Engineer in compliance to Makati City Office of the Building Officials memorandum.

# III. Checklist of Eligibility, Technical and Financial Components

The checklist of eligibility, technical and financial components is provided herein as ANNEX A.

# IV. Reminders

(Using the prescribed format in Section VIII. Bidding Forms of Bidding Documents p. 87)
- 5. Attachment of the Statement of SLCC:
  - 5.1 Certified true copy of Certificate of Satisfactory Completion issued by the client for the SLCC;

- 5.2 Certified true copy of official receipt(s) issued to the company for the SLCC
- The Bidder shall submit the following:
  - 6.1 NFCC computation in accordance with ITB Clause 5.5; and
  - 6.2 2017 Audited Financial Statements, showing, among others, the bidder's total and current assets and liabilities stamped "received" by the Bureau of Internal Revenue (BIR) or its duly accredited and authorized institutions;

or

6.3 A committed Line of Credit from a Universal or Commercial Bank which must be at least equal to ten percent (10%) of the ABC to be bid or Two Hundred Thousand Pesos (#200,000.00). If issued by a foreign universal or commercial bank, it shall be confirmed or authenticated by a local universal or commercial bank.

# Class "B" Documents:

- 7. The Bidder shall submit if applicable:
  - 7.1 Valid Joint Venture Agreement (JVA), in case the joint venture is already in existence;

or

- 7.2 In the absence of a JVA, duly notarized statements from all the potential joint venture partners, stating that they will enter into and abide by the provisions of the JVA in the event that the bid is successful. Failure to enter into a joint venture in the event of a contract award shall be ground for the forfeiture of the bid security.
  - 7.2.a <u>Each partner</u> of the joint venture shall submit their respective <u>PhilGEPS Certificate of Registration</u> (<u>Platinum Membership</u>) in accordance with Section 8.5.2 of the IRR of RA 9184. The submission of technical and financial eligibility documents by any of the joint venture partners constitute compliance: Provided, that the partner responsible to submit the NFCC shall likewise submit the Statement of all its ongoing contracts and Audited Financial Statements.
