SUPPLEMENTAL/BID BULLETIN NO. 1

Please be advised of the following Amendments/Clarifications in the Bidding Documents raised during the Pre-Bid Conference held on October 9, 2019:

A. SECTION III. BID DATA SHEET (BDS)

➤ **12.1(a)(i) – PhilGEPS Certificate of Registration**

As indicated in the BDS ITB Clause 12.1(a), for 12.1(a)(i) the Bidder shall submit a valid PhilGEPS Certificate of Registration of Membership under Platinum category including "Annex A" - (Platinum Membership) in lieu of their Class "A" Documents uploaded and maintained current and updated in the PhilGEPS pursuant to Section 8.5.2 of the 2016 Revised IRR of RA 9184.

➤ **12.1 (a)(ii) – Statement of All On-Going Government and Private Contracts and Single Largest Contract (SLCC)**

As indicated in the BDS ITB Clause 12.1(a)(ii) the Bidder shall submit the following:

- Statement of **All On-Going** Government and Private Contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid.
- Statement of **Single Largest Completed Contract (SLCC)** similar to the contract to be bid, within the past five (5) years prior to the date of submission and receipt of bids, the value of which must be equivalent to at least fifty percent (50%) of the ABC.

The Bidder shall attach certified true copy of Certificate of Completion and/or Acceptance issued by the client or official receipt(s) for the SLCC listed in the Statement of SLCC.

- The bidder shall certify as true copy of the "Certificate of Completion and/or Acceptance" and retain the original copy of the said certificate in their possession.

➤ **12.1(a)(iii) - The Bidder Shall submit any of the following:**

1. **NFCC computation** in accordance with ITB Clause 5.5 and **2018 Audited Financial Statements**, showing, among others, the bidder's total and current assets and liabilities stamped "received" by the Bureau of Internal Revenue (BIR) or its duly accredited and authorized institutions; **or**
2. **A committed Line of Credit from a Universal or Commercial Bank** which must be at least equal to ten percent (10%) of the ABC to be bid or Three Hundred Ninety Thousand Pesos (P390,000.00). If issued by a foreign universal or commercial bank, it shall be confirmed or authenticated by a local universal or commercial bank.

An Undertaking duly signed by an authorized representative and notarized, stating to submit the appropriate licenses and permits as required by law and stated in the BDS such as DOLE Registration and Current Certificate of Compliance to the General Labor Standards.	3. An Undertaking duly signed by an authorized representative and notarized, stating that they will submit the appropriate licenses and permits as required by law and stated in the BDS such as DOLE Registration.

B. SECTION VI. SCHEDULE OF REQUIREMENTS

- Motorized Messenger – the Motorcycle needed is at least 100cc, with gasoline provision.
- The Motorcycle to be issued to the motorized messenger assigned at NDC shall be owned by the Agency.

C. SECTION VII. TECHNICAL SPECIFICATIONS

- Item 3. The insurance coverage for accidents stated in this item is for all the personnel that will be assigned at NDC.
- Statements of “Comply” or “Not Comply” must be supported by evidence in the Bidders Bid and cross-referenced to that evidence.


4. FINANCIAL BID

1. **Number of Applicable Workdays/Year:**

- 261 days for Monday to Friday
- 313 days for Monday to Saturday

Supplemental/Bid Bulletin No. 1 is issued to modify or amend items in the Bidding Documents. This shall form an integral part of the Bidding Documents.
