BID BULLETIN NO. 3

PROCUREMENT FOR THE SUPPLY AND DELIVERY OF VARIOUS FURNITURE FOR THE NATIONAL DEVELOPMENT COMPANY (NDC) OFFICER'S ROOM AND FOR LACTATION AREA / TEMPORARY CLINIC

(Project Reference No. MR22-03-042)

This **Supplemental/Bid Bulletin No. 3** is being issued in relation to matters arising from queries of the prospective bidder during the Pre-Bid Conference conducted on June 9, 2022 and to modify and/or amend items in the Bidding Documents. This shall form an integral part of the bidding documents.

1. Query: In the items shown (photos) at Annex A, B and C, pages 91-108 of the Bidding Document, is it necessary that the same and exact items will be supplied?

Answer: The **MINIMUM** requirements are described per item. Please refer to Section VII **TECHNICAL SPECIFICATIONS** of the Bidding Document for the description, dimension and specification, which is indicated per furniture/item.

Bidders may offer items of better quality or specifications; however, it would be subjected to NDC's approval.

2. Query: Are bidders allowed to conduct site inspection or on-site measurements to verify actual sizing, i.e. on the size of the curtain partitions at Lactation Area?

Answer: Bidders are allowed to conduct site inspection to verify on-site measurements.

On the installation of the curtain partition at Lactation Area, the length is approximately at seven (7) linear meters.

3. Query: Please confirm size/dimension of the Vanity Mirrors.

Answer: For Vanity Mirrors, the dimension is 1.20 m x 0.90 m

4. Query: Please confirm size/dimension of the mini refrigerator wooden cabinet

Answer: For the mini refrigerator wooden cabinet, the dimension is 832 mm x 470 mm x 505 mm

5. Query: Please confirm chair (weight) tolerance, if any.

Answer: For guest chairs, tolerance is at-least 250 lbs and for mid back and high-back chairs, tolerance range is from 300 to 800lbs.

6. Query: Please confirm full specifications (material, size and thickness) of the bed, including the foam mattress.

Answer: BED SPECS: 80 x 36 inches; height range of 15" - 20"; and weight capacity of 450 lbs., material – steel framing

FIRM FOAM FIBER MATTRESS: The medical mattress is made with high performance fiber and measures 80" x 36" with a 6" depth. The cover is an easy to clean vinyl in frost green.

7. Query: Do we have specific brand of the fabrics or leatherettes for the sofas, seats and chairs?

Answer: No specific brand/s for the fabrics and leatherettes. Finishes will be subjected to NDC's approval.

8. Query: Please confirm if the conference table requires with wire management.

Answer: WITHOUT wire management.

9. Query: Please confirm tufting details (seat and back rest) of 2-Seater Sofa (S3).

Answer: Please refer to the minimum description on Sofa S3 - fully upholstered sofa with simulated loose seat and back cushion. Note tufting detail on seat and backrest. Metal legs/base in matte finish and subject for NDC's approval.
