1. Query: Please provide full description of the Breastfeeding Chair.

2. Query: The foot stool as shown in the sample photo together with the Breastfeeding Chair. Please confirm inclusion of the stool in the items for bidding.

Answer: Breast Feeding Chair is inclusive of the foot stool.

3. Query: Are bidders allowed to suggest/offer items/furniture on the bid, like the sample photos?

Answer: The bidders may suggest/offer furniture on its bid if it complies to the minimum requirements and specifications set in the Bidding Documents and will be subjected for NDC's approval.

4. For photos of the furniture, please refer to Annex A (Photos) of the Bidding Document.
5. All bidders are reminded of the Post-Qualification process, and we reiterate:
"During post-qualification, the procuring entity verifies, validates and ascertains all statements made, including compliance to the technical specification of the bid and the documents submitted by the bidder with the Lowest Calculated Bid (LCB). Post-qualification of bidders is according to the rank of bids from lowest to highest."
