BID BULLETIN NO. 3

PROCUREMENT FOR THE DESIGN AND BUILD OF AUTOMATIC FIRE SPRINKLER SYSTEM (AFSS) AND FIRE DETECTION AND ALARM SYSTEM (FDAS) AT THE INDUSTRY & INVESTMENTS (I&I) BUILDING (2nd Public Bidding)

(Project Reference No. MR21-12-135)

This **Supplemental/Bid Bulletin No. 3** is being issued in relation to matters arising from queries of the prospective bidder during the Pre-Bid Conference conducted on October 7, 2022 and to modify and/or amend items in the Bidding Documents. This shall form an integral part of the bidding documents.

1. Query: On the restoration of ceiling, and upon inspection of the I&I Building, the existing ceiling finishes/panels are likely to be damaged just by removing. Are bidders liable to replace such damaged items?

<u>Answer:</u> Works pertaining to temporary or permanent access at ceilings or the like needed during the construction stage was considered, likewise, for its restoration works. We refer to the Terms of Reference (TOR), Item B. Construction Stage, page 35:

- Provision of temporary and permanent access e.g., manholes or openings at ceilings, walls and slabs needed during construction.
- Restoration/making good of any temporary access/manholes at ceilings, walls and slabs being done during construction.

Provisions for the restoration/making good should include necessary masonry, plastering, sealants, painting or carpentry works as needed.

However, for damaged items, the Winning Bidder shall be responsible for such replacements.

The Bill of Quantities (BOQ), under Preliminaries, allows bidders for the provision for restoration works which includes replacement of such as needed.

Query: What would be the working schedule during the implementation of the

Project?

<u>Answer:</u> The I&I Building caters the Offices of the Department of Trade and Industry (DTI) and the Board of Investments (BOI), which, the normal operating working/office hours of both offices cannot be interrupted or disrupted.

Hence, on the implementation of the Project, during the <u>Construction Stage / Installation of AFSS/Fire Pro and FDAS</u>, works may proceed after office hours on weekdays.

And, on weekends (Saturday and Sunday), the Winning Bidder may work 24-hours.

Winning Bidder shall apply for a working permit in advance to secure NDC, DTI and/or BOI approval prior to the start for every work and location.

For the time or duration of works of the Project, please refer to Section VIII, Terms of Reference of the Bidding Document, pages 39-41.

3. For the conduct of site inspection at the I&I Building, we reiterate ITB Clause 8.0 of the Bidding Document, the schedule for the conduct of ocular inspection by the bidders shall be until October 6, 2022.
