A. MINIMUM QUALIFICATIONS

2. Must have at least five (5) years of experience as a management systems auditor / trainer / consultant for ISO 9001:2015 Quality Management System (QMS);
3. Must have an experience in providing consultancy services or at least an experience in auditing a government financial institution / government corporation or agency;
4. Must have previous clients which passed ISO 9001 certification;
5. Must at least be a bachelor degree holder in business administration or other related course; and
6. Must have at least five (5) trainings conducted within the last five (5) years relative to ISO.
