With at least one (1) existing contract with a total cost equivalent to at least fifty percent (50%) of the total Approved Budget for this Contract (ABC) or should have completed at least three (3) similar contracts, the aggregate amount of which should be equivalent to at least fifty percent (50%) of the ABC."</i></li> <li>If the bidder has no existing similar contract, they will be disqualified if they join on the bidding?</li> </ul>	A bidder can be disqualified if they have no existing similar contract. The requirement states that the bidder must have at least one existing contract with a total cost equivalent to at least fifty percent (50%) of the total Approved Budget for the Contract (ABC) or must have completed at least three similar contracts with an aggregate amount equivalent to at least fifty percent (50%) of the ABC. Failing to meet these criteria would result in disqualification.
