## RE : TRANSMITTAL OF 2020 PERFORMANCE SCORECARD

This is to formally transmit the 2020 Charter Statement and Strategy Map (*Annex A*) and 2020 Performance Scorecard (*Annex B*) of NDC.

The NDC-proposed Charter Statement, Strategy Map and Performance Scorecard submitted through its letter dated 30 September 2019<sup>1</sup> were <u>MODIFIED</u> based on the discussions made during the technical panel meeting (TPM) held on 11 December 2019 and evaluation of revised documents submitted through its letters dated 26 December 2019<sup>2</sup> and 15 July 2020.<sup>3</sup> We note, however, that NDC was not able to submit a Board Resolution approving the submission of the foregoing requirements.

We take this opportunity to inform NDC that Item 5 of GCG Memorandum Circular No. 2017-02<sup>4</sup> mandates GOCCs to submit Quarterly Monitoring Reports and upload the same in the GOCC's website within thirty (30) calendar days from the close of each quarter. NDC is requested to submit its revised Quarterly Targets based on the attached scorecard upon submission of the 3<sup>rd</sup> Quarter Monitoring Report for 2020.

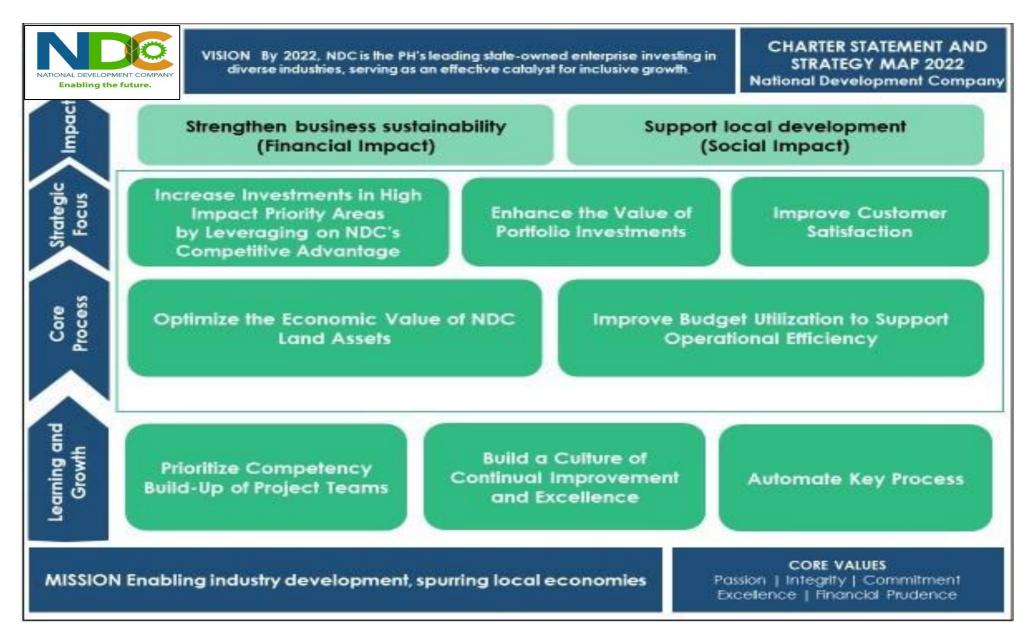
